1. Welcome and Chair's Comments

The Chair welcomed all to the meeting in particular Kathryn Jenkins, Deputy Chief Security Officer, Welsh Government.

The Chair gave an update on the key events and meetings he had attended since the previous Board meeting:-

 Brexit: Shaping the Future of Welsh Agriculture.
- 26 January 2018 The Chair partook as a panellist at the Agri Academy Alumni 2012 – 2017 reunion.
- 8 February 2018 The Chair joined key industry stakeholders at a lunch with Stuart Andrew MP, UK Minister for Wales & The Hon George Eustice MP, Minister of State for Agriculture, Fisheries & Food at the Royal Welsh Showground.

The purpose of the summit, attended by stakeholders from across the beef and lamb sectors was to reaffirm the challenges facing the sector and how the industry could work together to ensure resilience through difficult times in particular post Brexit.

HCC's Vision and Strategic Direction to 2025 (HCC 791)

A draft design of the publication was tabled and approved by the Board.

The Welsh translation was complete.

It was agreed that the Royal Welsh Grassland event to be held at Carnbwll, Four Crosses, Powys on Wednesday 16 May 2018 would be a suitable platform for the launch. The Communications Manager would progress with arrangements and report to the Board in due course.

It was noted that discussion was underway with the Welsh Government to ensure that the Welsh Red Meat Industry Strategic Action Plan (Action Plan until 2020) was aligned with the HCC Vision to 2025 to avoid duplication and to ensure an orderly transition would be achieved.

Red Meat Sector Supply Chain Integrity Programme trip to New Zealand (Defra Study Tour)

The Chair would provide a report on the above to the Board ahead of the April 2018 teleconference.

£50m EU Transition Fund financial and tailored support as the UK prepares to leave the EU)

The CEO was in dialogue with Welsh Government Officials regarding the above and would report to the 3 May 2018 Board meeting.

Sector Readiness – post Brexit

HCC was currently working with Welsh Government Officials on areas of contingency planning in a number of areas including scoping the future potential to address seasonality of production and interventions to balance supply and demand in the retail and foodservice sectors.

Work would also commence on the future production of lamb and beef in the hills / uplands allied to providing environmental outcomes. Work on lamb eating quality was proposed as part of the Strategic Initiative.

This was initial development work and the Board would be asked to contribute to this in due course.

This event was aimed at smaller abattoirs seeking to explore opportunities for collaborative approaches to dealing with and reducing waste more efficiently and therefore increasing business profitability.

8. **HCC Committees**

Communications Advisory Committee

It was noted that the Committee was considering ideas and options for the delivery of the HCC Annual Conference 2018 and would report to the Board at the 3 May 2018 meeting.

The Committee Chair reported on the above:-

- A presentation on an RDP funding application regarding Smart Packaging was particularly interesting and relevant.
- Some invitations for the extended membership of the Committee had still to be taken up and further contact would be made with the relevant organizations to encourage attendance.

- A briefing on the R&D projects that HCC was currently supporting would be provided to the Board in due course.
- The Industry Development and Relations Manager reported that a meeting had been held with AHDB to discuss the priorities for R&D activity to be funded by the ring-fenced levy money. The following areas had been identified and would be considered further:-
 - 1) Responsible antibiotic use
 - 2) Health and welfare monitoring
 - 3) Coordinated approach to biosecurity
 - 4) Optimum mature size in breeding animals
 - 5) Ensuring accuracy of forage analysis

9. To receive and update on the GB Red Meat Levy Distribution

Due to time constraints, this item was deferred for discussion and would be placed on the agenda for the April teleconference.

10. <u>To receive a verbal update on HCC's application for RDP funding 2014 – 2020 on behalf of the Red Meat Industry</u>

The Executive continued to work on the applications following feedback from the Welsh Government. The applications would be resubmitted with a hopeful and imminent outcome from Welsh Government.

The Chair stated that this funding remained essential for delivery of the HCC strategy on behalf of the Welsh red meat industry.

11. <u>To discuss the recent Hygiene and Food Safety breaches and its effect on</u> consumer confidence

The Chair thanked Kathryn Jenkins for a very interesting and informative presentation and stressed the importance of maintaining effective organizational policy and practice to address the risks highlighted.
